## 5. Fire-fighting measures

## 6. Accidental release measures

Collect dust using a vacuum cleaner equipped with HEPA filter. Stop the flow of material, if this is without risk.  Large Spills: Wet down with water and dike for later disposal. ## 7. Handling and storage
