### 2. HAZARDS IDENTIFICATION

**Emergency Overview:** WARNING! May irritate the eyes. May irritate the skin. Avoid breathing dust. May irritate the lungs.

#### 4. FIRST AID MEASURES

<b>On Skin:</b>	Wash with soap and water. Remove contaminated clothing and launder before reuse. Destroy or properly dispose of contaminated shoes. If irritation persists or signs of toxicity occur, seek medical attention.
<b>Inhaled:</b>	Remove person to fresh air. If not breathing, give artificial respiration. If breathing is difficult, get immediate medical attention. If inhaled, remove from area to fresh air. Get medical attention if respiratory irritation develops or if breathing becomes difficult.

#### 6. ACCIDENTAL RELEASE MEASURES

#### 7. HANDLING AND STORAGE

<b>Handling:</b>	Avoid contact with skin and eyes. Avoid breathing dust; if exposed to high dust concentration, leave area immediately. Keep away from food and smoking materials. Good hygienic practices should be observed. Work clothes should be washed separately at the end of each work day. Disposable clothing should be discarded with material. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Do not reuse this container. Storage at temperatures above 90 F for an extended period of time should be avoided. Reclose containers of unused product. Keep containers tightly closed when not in use.
<b>Storage:</b>	Store closed containers in a cool, dry, well-ventilated area. Store away from strong oxidizing materials. Avoid exposure to direct sunlight. Storage at temperatures above 90°C is NOT recommended.
